#### **NOTIFICATION**

New Delhi, 8th May, 2015

- **G.S.R. 371(E).**—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of Central Fertiliser Quality Control and Training Institute, Faridabad (Law Officer) Recruitment Rules, 1995, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules, regulating the method of recruitment to the Group 'A' post of Law Officer in the Central Fertilizer Quality Control and Training Institute, Faridabad, under the Department of Agriculture and Cooperation, Ministry of Agriculture, namely:—
- 1. **Short title and commencement** .-- (1) These rules may be called the Central Fertilizer Quality Control and Training Institute, Faridabad, Law Officer (Group 'A' post) Recruitment Rules, 2015.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Application.** These rules shall apply to the post specified in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classification and pay band and grade pay or pay scale.-- Number of the posts, its classification, pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of Schedule annexed to these rules.
- 4. Method of recruitment, age limit, qualification, etc. The method of recruitment, age limit, qualifications and other matters relating thereto shall be specified in columns (5) to (13) of aforesaid Schedule.
  - 5. **Disqualification.-** No person,-
    - (a) who has entered into or contracted a marriage with a person having a spouse living; or
    - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to marriage and that there are other grounds for so doing, exempt any person from operation of this rule.

- 6. **Power to relax.-** Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of provisions of these rules with respect to any class or category of persons.
- 7. **Saving.-** Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-servicemen, Other Backward Classes and other special categories of persons in accordance with orders issued by Central Government from time to time in this regard.

- G.S.R. 372(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Central Fertiliser Control Laboratory, Faridabad (Group A and Group B posts) Recruitment Rules, 1979, in so far as they relate to the post of Administrative Officer and Central Fertiliser Quality Control and Training Institute, Faridabad (Group 'C' and Group 'D' posts) Recruitment Rules, 1977, in so far as they relate to the post of Superintendent, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules, regulating the method of recruitment to the Group 'A' post of Administrative Officer and Group 'B' post of Office Superintendent in the Central Fertilizer Quality Control and Training Institute, Faridabad, under the Department of Agriculture and Cooperation, Ministry of Agriculture, namely:-
- 1. Short title and commencement .-- (1) These rules may be called the Central Fertilizer Quality Control and Training Institute, Faridabad, Administrative Officer and Office Superintendent (Group 'A' & 'B' posts) Recruitment Rules, 2015.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- **2. Application.** These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classification and pay band and grade pay or pay scale. -- Number of the posts, its classification, pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of Schedule annexed to these rules.
- **4. Method of recruitment, age limit, qualification, etc.** The method of recruitment, age limit, qualifications and other matters relating thereto shall be specified in columns (5) to (13) of aforesaid Schedule.
  - 5. Disqualification.- No person,-
    - (a) who has entered into or contracted a marriage with a person having a spouse living; or
    - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to marriage and that there are other grounds for so doing, exempt any person from operation of this rule.

- **6. Power to relax.-** Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of provisions of these rules with respect to any class or category of persons.
- **7. Saving.-** Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-servicemen, Other Backward Classes and other special categories of persons in accordance with orders issued by Central Government from time to time in this regard.

- (ii) With three years regular service in the Grade rendered after appointment thereto on a regular basis in Pay Band-2 (Rs.9300-34800), with Grade Pay Rs.4600/-; or
