Agriculture & Allied Trade between India and China

- 1. Exports: In the year 2018-19, India's total export of agricultural and allied commodities to China was of the order of US \$ 1999 million, approximately 117 % higher than the previous year. (Table -1)
 - Major Exports: raw cotton, other shrimp & prawn, castor oil, Capsicum-Pimenta etc.
 - b) **Minor Exports:** Cuttle Fish, Black Tea, Crabs, Ground Nut oil etc.
- **2. Potential Items of Export:** Wheat and meslin, vegetable seeds, food Preparations for infant use, malt extracts, food preparations n.e.s., preparations of a kind used in animal feeding etc. (Table -3)
- **3. Imports:** In the year 2018-19, India's total import of agricultural and allied commodities from China was of the order of US \$ 282 million, approximately 19 % lower than the previous year. (Table -2)
 - a) Major Imports: animal feeding, kidney beans, bamboos, wheat gluten etc.
 - b) **Minor Imports:** Apple juice(Other), Active yeast, Poppy seeds etc.
