India-Kyrgyzstan Trade Brief

Agriculture & Allied Trade between India and Kyrgyzstan

- **1. Exports:** In the year 2021-22India's total export of agricultural and allied commodities to Kyrgyzstan was of the order of US \$ **1.76**million, approximately **5** % higher than the previous year. (Table -1)
 - a) **Major Exports:**Tea, Spices, Ayush and Herbal Products, Misc Processed Itemsetc.
 - b) **Minor Exports:** Processed Fruits and Juices, Rice –Basmoti,Tobacco Manufacturedetc.

2. Potential Items of Export:

- a. New Items:Fresh grapes, "Dried, shelled chickpeas ""garbanzos"", whether or not skinned or split", Wheat and meslin (excluding seed for sowing, and durum wheat), Tomatoes, fresh or chilled,Fresh or dried bananas (excluding plantains)etc., (Table -3)
- **b. Existing Items:** Semi-milled or wholly milled rice, whether or not polished or glazed(Table -4).
- 3. Imports: In the year 2021-22, India's total import of agricultural and allied commodities from Kyrgyzstan was of the order of US \$ 1.69 million, approximately 574 % higher than the previous year. (Table -2)
 - a) Major Imports: Pulses, Spices, Fresh Fruits etc.

4. Potential agriculture items of India's export to Kyrgyzstan

a. New Items Methodology

- Items in which Kyrgyzstan's imports of agricultural items from India were negligible during 2021.
- The global import of Kyrgyzstan in these tariff lines and global exports of these commodities by India is over US \$ 4 million.
- Turkmenistan may explore the possibility of sourcing these agricultural items from India. Sanitary Phyto-sanitary (SPS) and other requirements in respect of these products may be sought from Kyrgyzstan.

b. Existing Items Methodology

 To arrive at the potential items in existing agricultural items, share of India's exports in Kyrgyzstan's import along with share of India's exports to Kyrgyzstanviz-a viz world has been studied.
